TOUR CONDITIONS

LINGUA MUSICA TOUR SEPTEMBER 2013

1. All fees must be paid by the due dates. (Deposits: By 28th March 2013. Balance BY 4th July 2013)
2. This tour has been costed according to the exchange rate of 16th September 2012. If there is a negative fall by more than 3.5% before the Full Tour price has been paid, this difference must be passed on to the consumer.
3. A condition of this tour is that you take out travel insurance. Full details of your insurance must be advised in writing to Lingua Musica by 60 days before departure
4. A condition of this tour is that Lingua Musica must be advised of any health problems you may have and any on-going medications needed on tour. Lingua Musica cannot accept responsibility for providing or handling medications on tour.
5. Whilst out tours are conducted in a relaxed manner, participants need to be reasonably fit and able to handle their own luggage in public places (eg. Airports and train stations) and able to negotiate stairs and uneven surfaces (like cobbled stones) if necessary. Our guided walking tours are normally two hours in duration. Our qualified guides require assurance from Lingua Musica that all participants can maintain a reasonable pace.
6. The Lingua Musica tours are offered as a total package. We are unable to refund any components on tour not taken. Lingua Musica will not accept responsibility for any illness or misadventure suffered by any participant on tour.
7. If, for any reason Lingua Musica must cancel this tour, all tour monies would be returned in full. Lingua Musica would never cancel a tour within 60 days of departure unless forced to do so because of war or similar circumstances. As with all such tours, the viability of the tour depends on a minimum tour number ... in this case, ten participants.
8. Performance tickets purchased on your behalf are purchased on a "no refund for cancellation" basis. Participants need to be aware of this.
9. Lingua Musica asks you to accept that in very rare instances some arrangements made with international bodies may require small itinerary changes. Also participants need to understand that on a Music-related tour, full details of performances are usually not known till about 6-4 months ahead of departure. The number and quality of performances though are guaranteed.
10. CANCELLATION POLICY:

29 th March – 4 th May 2013:	Forfeit of 20% of the deposit
5 th May – 4 th July 2013:	Forfeit of full deposit
5 th July - 4 th August 2013:	Forfeit of 50% of the full tour price
After 4 th August 2013:	Forfeit of the full tour price

(These conditions are imposed upon Lingua Musica and it is obvious why travel insurance should be in place early.)

11. Application to join this tour must be made directly to Lingua Musica. Acceptance of the tour conditions to be acknowledged on booking form. Places on the tour will be allocated in order of receipt of bookings. It is deemed necessary to make bookings well ahead of Closing Date.

12. ROUND-THE-WORLD AIR FARES:

These will be handled by our experienced senior travel advisor (see details on booking form.) The exact price for 2013 will be available at the end of October 2012. Airline taxes at the time will also be advised but it needs to be understood that these taxes can rise before payment. LINGUA MUSICA offers a full tour package including the RTW flights (which will be very flexible from New York) but the actual flights bookings for Australian participants must be done through our travel advisor. Overseas applicants may discuss a different method of accessing necessary flights.
