- 1. Acceptances on this tour will be made in order of receipt of signed Booking Forms and Conditions, accompanied by the advised deposit.
- 2. Individual Travel Insurance is a requirement of this tour. The full details of your travel insurance must be made known to LINGUA MUSICA in writing by two months before commencement of the tour.
- 3. The Cost of this tour has been arrived at according to the rate of exchange between the EUR and AUD at the following date: <u>September 15/9/14.</u>
 - If this rate alters negatively by more than 3 ½ % the resultant increased cost to Lingua Musica must be passed on to the tour participant.
- 4. Deposit and Final Balance of payment must be made BY the advised dates. Payment may be made by cheque to Lingua Musica or by direct deposit. (Details available on request at time of payment).
- 5. It is a requirement that participants MUST advise Lingua Musica of any health problems they may have and also any medications they may be on during the tour. (This is purely for the safety and well -being of the participant.)
- 6. Lingua Musica does not accept the responsibility of carrying nor administering medications for participants.
- 7. Lingua Musica asks you to accept that in rare instances, we may need to change some small details pertaining to this tour...ie. Time changes when a European body makes a change. You would always be informed ahead of any such change of arrangement.
- 8. Lingua Musica will not refund any parts of this tour (eg. Any excursions etc) which a participant does not do. Nor any performances missed.
- 9. Tickets for performances made on your behalf are non-refundable.
- 10. Cancellation Policy: After deposit is paid and up till Feb. 28th: 5% of deposit.

March 1st - May 31st: 50% of tour cost.

From June 1st: 100% of tour cost

- 11. Requests for any pre-tour and/or apres-tour accommodation and other arrangements must be made at time of booking. These arrangements will be costed separately and must be paid in full when requested to do so by Lingua Musica.
